1. Apologies (Annex 1)

The meeting is attended on site by Hans Westulund (RSAI president); Tomaz Dentinho (Councillor at large); Rosella Nicolini (PiRS Editor in Chief); Daniela Constantin (Councillor at large); André Chagas (Councillor at large); Carlos Azzoni (LARSA delegate); Katarzyna Kopczewska (Councillor at large); Patricio Aroca; Soushi Suzuki (PRSCO Executive Director); Hiroyuki Shibusawa; Elisabete Martins; Andrea Caragliu (RSAI Executive Director); Roberta Capello (ERSA President); Camilla Lenzi (Councillor at large), and online by Haifeng Qian (NARSC delegate) and Lise Bourdeau-LePage (ERSA delegate)

At 12.45 the RSAI president opens the meeting and welcomes participants.

2. Approval of the minutes of the Apr. 10, 2024 meeting (Annex 2)

Hans Westlund asks if anybody has any comments on the minutes, which were circulated before by the Executive Director by email. As no requests for changes to the minutes are presented, the minutes are unanimously approved.

3. Selection of new RSAI Executive Director (Annex 3)

This crucial item is introduced by the RSAI President Hans Westlund. He explains that candidates will first present themselves, then they will leave the room and the Council will make a decision based on both the presentations, the recommendations of the search committee, and the material circulated before.

Candidates are let in. Two (Balazs Forman and Rafael Garduno-Rivera) attend online, three (Marco Modica, Ana Viñuela, and Carolina Guevara) attend on site. Presentations follow the alphabetical order. First, Prof. Balazs Forman (no question were asked after his presentation), then Prof. Rafael Garduno-Rivera, Prof. Carolina Guevera, Prof. Marco Modica, and Prof. Ana Viñuela. Rafael Garduno-Rivera is asked by Prof. Dentinho how he plans to finance the workshops he proposed for his possible future role as ED. Prof. Garduno-Rivera replies he would seek extra funding from different sources.

Prof. Guevara introduces her candidature with a short bio, and quickly moves to her possible plans for the association. She reports about her experience in presiding over the Ecuadorian section, and adds she would like to extend this experience in managing the RSAI. Her focus would be on extending the number of sections, and on attracting more individuals and making existing ones more active. Andrea Caragliu asks her whether she would have plans to revive LARSA's supranational section's activities.

Marco Modica introduces his candidature with a short bio. He reports a long history of RSAI membership. The focus of his possible term as ED would be to enhance the collaboration among supranational and national sections. He also adds that he would like to disseminate more knowledge about the various roles played by the association to its members. Carlos Azzoni asks if he would get institutional support. Marco Modica replies his rector supports his candidacy, and since GSSI is a research-oriented institutions, teaching duties are already lower than the Italian average. Tomaz Dentinho challenges Prof. Modica's idea of enhancing the network component of the RSAI against its present hierarchical structure.

Ana Viñuela places her candidature within the context of her research group, and the Spanish section's. She also reports that she would like to walk in the footsteps of the previous management, with a particular focus on reviving dormant sections.

Candidates are requested to leave the room. The discussion starts. Carlos Azzoni underlines that institutional support, and gender balance should be taken into account.

Andrea Caragliu explains the recommendations of the search committee, and the rules (two-stages vote as suggested by the LRPC). Tomaz Dentinho advises against this system for the so called Arrow dilemma. Patricio Aroca agrees that three candidates are outstanding, and suggests to vote only for them. Lise Bourdeau expresses concerns about this and suggests to keep all five candidates at least in a first vote.

Roberta Capello gets back to the core of the point – the quality of the candidates. She adds that one candidate, Prof. Viñuela, stood out in terms of proposing managerial, rather than strategic, issues. Katarzyna Kopczewska concurs with her opinion. Tomaz Dentinho stresses that three candidates traveled to Terceira to present their candidatures, and traveling for work is an important part of being an ED.

After a fruitful discussion, the Council proceeds to voting. Within the Council, 11 voting members opt for Ana Viñuela, while one member abtains. Candidates are let in again; they are notified of the outcome of the decision, and Prof. Viñuela is congratulated on achieving this important position. At the same time, the Council expresses gratitude to all candidates for their effort and candidatures, and hopes to count on them for future executive roles in the association. The candidates are also invited to stay for the rest of the Council, to see how the mechanisms work.

4. Opening for council representatives from supranationals (end of term for Brian Kim, PRSCO; and Sandy dall'Erba, NARSC)

Andrea Caragliu explains the usual round of openings. Soushi Suzuki says that in the PRSCO congress in Korea this item was discussed, and a name will be provided within the end of this year. Haifeng Qian will ask the NARSC Council to provide a name in due time.

5. Opening for one at-large councilor (end of term for Tomaz Dentinho)

Andrea Caragliu notifies the council that in 2025 a new position for RSAI Councillor at large will be released, and suggests NARSC, PRSCO, and LARSA to motivate good members to apply.

6. Opening for nurturing talent proposals

Andrea Caragliu explains that a budget comparable to previous years is available, and suggests sections – especially NARSC – to leverage on it.

Tomaz Dentinho asks if there is extra money for Asia and Africa. Andrea Caragliu replies some budget for African events is still available, while for Asia proposals will have to go through the PRSCO-allocated budget. Prof. Dentinho recommends the group organizing Central Asian events to the PRSCO Councilors attending the meeting.

7. 2023 Report and Accounts (Andrea Caragliu) (Annex 4)

Andrea Caragliu reports about the budget, stressing the now usual financial stability of the association, which shows for 2024 a tentatively even budget, although a profit will very likely to be made. This is due to the fact that with the new contract with Elsevier for publishing PiRS and RSPP, and unlike what previously done with Wiley, no revenues will be anticipated, but the whole royalties due to the RSAI will be sent by the Publisher early in 2025, although technically this budget is to be financially attributed to 2024.

8. 2024 Report of PiRS (Rosella Nicolini) (Annex 5)

Rosella Nicolini reports good numbers in terms of the journal's growing impact factor, submissions, and geographic diversity.

9. 2024 Report of RSPP (Tomaz Dentinho) (Annex 6)

Tomaz Dentinho reports that accepted papers went up by 25%, but so did citations, and that, as a consequence, the IF remained constant (equal to 1.7). He also plans to reduce the editors to 15, and to move from the strategy to collect special issues to one that is based on compiled ones.

10. Candidatures received for the 2026 World Congress (Annex 7)

Carolina Guevara is invited to present Ecuador's candidature. She explains that the Ecuadorian section and the *Escuela Politecnica National* will be the proponents. Patricio Aroca asks where the congress will be held and how many hotels will be available in close proximity. Prof. Guevara replies the venue will be the university, and that many hotels will be available in immediate proximity. A few questions revolve around the budget proposed, and the level of safety for congress participants. The Council agrees that a tentative interest in the location of Quito is there, but at the same time requires Prof. Guevara to fine-tune the proposal and deal in particular with a revision of the proposed budget, and the issues with safety. A final decision will be made at the Council meeting in New Orleans, during the NARSC congress, November 2024.

11. Opening of call for applications for new RSPP EiC, starting Jan. 1, 2026

Andrea Caragliu explains about the opening of the new Editor in Chief of Regional Science, Policy and Practice. Prof. Dentinho is stepping down as of December, 2025, and the Council would like to appoint a new incoming Editor in Chief to work along with Prof. Dentinho during 2025, and replace him in due time. A public call for applications will be released in September, and a search committee will be appointed to elicit good candidatures, and review them with a recommendation to be made to the Council. A decision on this position will be made at the Council meeting in New Orleans, during the NARSC congress, November 2024.

No other business is suggested.

13. Next meeting

With no more items to discuss, Prof. Westlund closes the meeting at 2.23 pm local time.

Annex 3

Recommendations of the RSAI ED search committee to the RSAI Council

The RSAI ED search committee, appointed by the RSAI Council during the meeting of the former at the 14th World Congress of the RSAI in Kecskemét, Hungary, is made up of Hiroyuki Shibusawa, Eveline Van Leeuwen, Tomaz Dentinho, and Andrea Caragliu.

The secretariat received five valid candidatures:

- Rafel Garduno
- Carolina Guevara
- Marco Modica
- Ana Vinuela
- Balazs Forman

The committee expresses satisfaction for the large number of high profiles candidatures received for the position. This is proof of the lively activity taking place within the Association.

The committee met electronically, also with the presence of Elisabete Martins, RSAI Secretariat, on July 10, 2024 to review and discuss the five valid candidatures received for the position of RSAI ED within the Jul. 1, 2024 deadline.

Ms. Martins reviewed the membership status of the five candidates, which reads as follows:

- Rafael Garduno 2020 and 2024
- Carolina Guevara from 2018 until 2024
- Marco Modica 2014, 2016, 2018, 2023 and 2024
- Ana Vinuela from 2014 until 2024
- Balazs Forman 2022, 2023 and 2024

Three candidates stand out in this respect, as Carolina Guevara, Marco Modica, and Ana Vinuela demonstrated consistent interest in the association through a very regular participation in activities. On Prof. Modica, Andrea Caragliu notifies the committee that the years when he did not appear as a regular member may be due to the peculiar status of the Italian Section of the RSAI (AISRe), which allows institutions to pay collective membership fees (*Socio collettivo*), allowing individuals working for the institution to participate in the AISRe yearly congress without paying individual fees.

The committee also agrees on reporting the council the following table, assembled by Tomaz Dentinho, and breaking down the letters of the candidates in terms of the topics mentioned:

Based on this table, among the current crucial issues characterizing the association and its needs, two candidatures standing out in terms of the attention to multiple items, viz. Ana Vinuela's and Marco Modica's. This suggests that these two candidates appear to be more knowledgeable about the current needs of the association. At the same time, Carolina Guevara's candidature still represents a possible viable alternative, despite the relative shorter experience in handling professional service. Between Prof. Vinuela and Prof. Modica, the Committee also recommends that the RSAI Council takes into account the fact that the Executive Director position was never held by a female in the past.

In conclusion: the RSAI ED search committee believes that two candidatures that appear particularly attractive for the position are Ana Vinuela and Marco Modica. The committee also believes that Carolina Guevara represents a good potential alternative. Lastly, despite their interest, the committee believes that the candidatures from Balazs Forman and Rafael Garduno Rivera appear to be slightly less attractive for the ED position.

Note from the Executive Director in 2023

In 2023 five RSAI Council Meetings have been held, some online, some onsite. The latter include meetings at the PRSCO summer institute in Siem Reap, Cambodia; the ERSA conference in Alicante, Spain; and the NARSC conference in San Diego, CA. The Council is happy to be back to PRSCO; and praises this supranational with its renewed efforts to extend its presence in Countries without an RSAI Section.

In 2023, the RSAI Council composition changed as follows:

- Hans Westlund replaced Eduardo Haddad as RSAI president;
- Lise Bourdeau-Lepage replaced Francisco Carballo as ERSA representative.

During 2023, the activities of the three newly activated committees (Diversity and inclusion committee; Communication committee; Honors committee) carried on. Across all committees, a better effort in coordinating activities, and in carrying out their mandates, would be welcome, as often the ED and the president had to remind the committees of their duties and schedule.

2023 was also characterized by witnessed growth in terms of scientific reputation of our journals. While *Papers in Regional Science*'s IF resumed its long run growth path (2.4 in 2023, 2.1 in 2022), *Regional Science Policy and Practice* maintained its first impact factor, 1.7, while oncreasing its CiteScore from .1 n 2022 to 3.6 in 2023. To both EiCs, the Council's thank-you for their great job. Last but not least, Mina Akharvan and Martijn Smit edited two issues of the RSAI Newsletter, published and distributed online by the RSAI in May and November 2023.

In terms of publications, the main event in 2023 was the decision to transition from Wiley to Elsevier, and from hybrid to Gold Open Access for both PiRS and RSPP. While the outcomes of this transition will be monitored over the next years, and the early findings commented in the 2025 ED report, we can already state this was a bold move, made by the Council to try and anticipate the market, and offer our membership impactful and solid scientific journals.

The RSAI usually organizes World Congresses every other year, and in 2022 two proposals were received, although neither was found to be fully convincing. The Council decided to freeze the decision and work on the proponents to open another call for applications, which took place in 2023, with the decision to host the 2024 World Congress of the RSAI in Kecskemét, Hungary, with the support of the LOC (John Von Neumann University), and the RSAI's Hungarian Section, MRTT. The congress will be commented in the 2024 report.

The Association gained further in the rebound to the record of individual members achieved a few years ago, and following the substantial decrease in members after the Pandemic hit. Members remained stable (4,370 in 2022, 4,245 in 2023). While the association is regaining positions, a note on some troublesome sections (in terms of lack of activities, delayed or missing payments, and difficult communications) is worth being discussed at future Council meetings.

In 2023 the Nurturing Talent programme the following initiatives have been approved for financial support:

- Workshop: Geo-Text Data Analysis in Regional Science: recent advances and best practices, "April/May 2023 (the date will be finalized based on the availability of invited keynote speakers), Tentative Venue: Academy Building, University of Groningen"
- WINTER COURSE FOR UKRANIAN ACADEMICS, "February/March 2023 (length of the event: 3 days), Alexandru Ioan Cuza University of Iasi, Romania"
- "2nd Southeast Asian Frontiers (SEAF) Workshop: Writing Highlands: Imperialism, Development, and Environmental Changes in Southeast Asian Highlands", "23th- 25th August 2023 in Yogyakarta, Indonesia. The host institution will be Universitas Islam Indonesia."
- ERSA Summer School 2023: The digital future of smart regions, "Date of the summer school: End
 of June/Beginning of July (the exact date will be established at a later date, for a good
 coordination with other regional science events). Venue: Centre for European Studies, Alexandru
 loan Cuza University of Iasi, Romania."
- "Regional Analysis of Input-output: Applications for Paraguay", "Place: National University of Asunción, University Campus of San Lorenzo, Paraguay. March 2023".

In 2023, the net profit for the exercise was equal to € 34 594,08. The Association's Bank Account availability increased from € 546,201.37 (brought forward from 2022) to € 582,157.66 as of Dec. 31, 2023. While the situation does remain florid for the accounts of the association, leaving enough cushion for a prolonged period of financial restraints (if any), two items deserve in my view the council attention: (i.) Some national sections tend to be difficult to reach, and provide belated payment, if any; some are in fact rather inactive, and the Council should in my view consider to eliminate them from the map and start all over again; (ii.) National sections payments are almost never sufficient for fully covering the expenses for all activities. A substantial portion of the Association revenues comes from the contract with the publisher, whose renewal is a crucial step for the association's finances, beyond its scientific activity.

To conclude, I would like to thank the whole RSAI Council, the Long Range Planning Committee, and the Council-appointed committees for their continuous support of RSAI activities. The Association keeps growing, and while it does face many challenges (in the publication landscape; in the relations with national and supranational sections; in terms of competition with other associations gathering members from germane disciplines), its truly global membership; its sense of belonging; and the quality of its members and representatives all bode well for successfully dealing with them.

The Hirotada Kohno Award



Daniela Constantin awarded the 2023 Kohno prize!

The committee (made up of Hans Westlund, RSAI president; Yoshiro Higano and Eduardo Haddad, LRPC members; and Lily Kiminami, RSAI Council member) in charge of selecting the recipient of the 2023 Hirotada Kohno award recommended Prof. Daniela Constantin (RRSA) to be the recipient of the award. The motivation provided by the committee reads as follows:

Dr Daniela Constantin, Professor of Regional and Urban Economics and Policy at the Bucharest University of Economic

Studies, Romania, has served the Regional Science community since the early 1990s. She has been the main character behind the establishment and development of the Romanian Section of the RSAI, for which she has served as President for over twenty years. Also, she is the Scientific Director of the

Romanian Journal of Regional Science (founded 2007).

Daniela Constantin has been a member of the ERSA Council for more than 20 years, and has over the years had an innumerable number of commissions for ERSA. Currently, she is one of the editors of the

"Papers in Regional Science" under Rosella Nicolini's leadership as well as a member of the editorial boards of "Regional Science Policy and Practice" and "Region". When the RSAI World Congress was held in Timisoara 2012, Professor Constantin served as Co-President of the Organising Committee. Thereafter, she has among other things been elected as Councilor-at-Large of the RSAI Council for two consecutive terms (2020-2022 and 2023-2025).

Dr Daniela Constantin's long-term, selfless involvement at different levels in the Regional Science community makes her a worthy recipient of the Kohno Award.

The Martin Beckmann RSAI Annual Award

The jury consisting of Budy Resosudarmo (PRSCO), William Strange (NARSC), Isabelle Thomas (ERSA) and Rosella Nicolini, EiC of the journal chose the article:

<u>Jhorland Ayala-García</u> and <u>Sandy Dall'Erba</u> (2022) <u>The Impact of preemptive investments on Natural disasters</u>, published in Papers in Regional Science, Volume 101, Issue 5, Pages 1087-1103.

Motivation:

This study delivers a very original contribution to the current and relevant debate on the role of institutions and public policies aiming at contrasting the socioeconomic impact of natural disasters on citizens' life. The authors implement a precise research strategy approaching physical geography to regional science. They exploit novel and original data combining satellite information with public finance data for Colombian municipality and propose different indicators for approximating the market and non-market losses of landslide-related events (associated with extreme rainfalls events due to climate change). The empirical analysis relies on a robust IV approach building on a very attentive selection of covariates fitting the proposed indicators. The conclusion is a direct message to institutions and policy-makers demanding effective measures to protect lives and assets of the most vulnerable population. as the winner of the Martin Beckmann Prize as the best paper published in Papers in Regional Science in 2022.

The Peter Nijkamp Research Encouragement Award

RSAI Dissertation Award



Dr <u>Yunyu Tian</u> is chosen as the winner of the RSAI dissertation award in 2023 for her PhD dissertation entitled "Earth Observation data for assessing global urbanization-sustainability nexuses", which was successfully defended (with a cum laude distinction) on 6 June 2023 at Wageningen

University and Research.

The cum laude distinction (only given to around 5% of all PhD students at Wageningen University) was awarded by an extended evaluation committee of nine persons. Dr Tian's PhD dissertation made significant contributions towards the knowledge of urbanization

and environmental changes at the global scale. The thesis included highly innovative methodological features such as the use of multi-source (and high quality) Earth Observation data and social data, contributing to academic and policy knowledge relating to global urbanization and sustainability as well as their nexus at the neighbourhood level. Part of the thesis has already been published in the form of academic peer-reviewed papers in the journals Landscape and Urban Planning (2022) and Environmental Research Letters (2022).

The RSAI congratulates Dr. Tian and her supervisors Professor Martin Herold and Professor Eveline van Leeuwen (Wageningen University).

The Jean Paelinck RSAI Award

<u>Prof. Paul Elhorst</u>, University of Groningen, the Netherlands, is awarded the 2023 edition of the Jean Paelinck award!

The Jean Paelinck committee, made up of Geoffrey Hewings (Chair), Isabelle Thomas, Janet Kohlase, Juan Cuadrado-Roura, and Kieran Donaghy, provided the following motivation:

Paul Elhorst is Professor of Spatial Econometrics at the University of Groningen, the Netherlands, Fellow of the Spatial Econometrics Association and Editor-in-Chief of the journal Spatial Economic Analysis. During his 40 years academic career he has maintained an active research and publication schedule, a career that demonstrates his commitment to research and scholarship in regional science methods. In the 1990s his research activities focused on regional labor market analysis and then shifted increasingly to spatial econometric methods (theory and applications), with applications in a diversity of research areas such as economic growth, research productivity, regional tax competition, military spending, foreign direct investment and transport economics.

Paul is known for his innovative work on spatial panel models. He has made a host of contributions to spatial panel data models highlighted in his 2014 book Spatial Econometrics: From Cross-Sectional Data to Spatial Panels. Aside from its major themes, including static and dynamic spatial panel data models, this book bridges the gap between theoretical spatial econometricians and practitioners, contains a host of useful observations and illustrations, and provides Matlab routines with which researchers can run on their own empirical problems. The more than 2,000 Google citations this book has received clearly demonstrate the international impact of his research in enhancing the use of regional science methods to understand and interpret the spatial structure of economies.

RSPP Annual Paper Award

The winners of the RSPP Annual Paper Award 2023 were:



Daniel S. A. Carvalho and Gervásio F. Santos (2022) Transport and density of population groups in the urban area of the city of Salvador. *Regional Science Policy Practice* 14(6), 234-253. https://doi.org/10.1111/rsp3.12496

The paper tries to find the effect of geographical features in transport accessibility for white and black in Salvador (Brazil), estimates and index of accessibility and applies a two-stage least square regression relating it to history using the proxy of geography (valleys), to density and to race. Conclusions indicate the trade-offs density and accessibility while indicating the effect of transport policies in the social profile or the urban structure. It is an important topic of human interaction within space, analysed with replicable methods and creative generation of data, leading to interesting policy awareness. The paper has a very nice background information on Salvador, focus an interesting topic with a well-executed analysis that includes physical geographic variables and using transport mode-choice issue which is important in Latin America.

Harry Aginta (2022) Spatio-temporal analysis of regional inflation in an emerging country: the case of Indonesia. *Regional Science Policy Practice* 14(3), 667-688. https://doi.org/10.1111/rsp3.12539

This paper analyzes regional inflation dynamics in Indonesia and, estimation a spatio-econometric model, finds the transmission of price changes from regions to regions. Results are very interesting for an archipelago but also can be very useful for large monetary areas. A study that is ahead and leads to

way to study the interaction between regional and monetary policies. It is an innovative space-time analysis. The adjustment to the Indonesian archipelago spatial context makes of an interesting application with the results for different components of inflation of general interest.

Report July 2024

Summary

The most salient results of Papers in Regional Science are:

- 1. **The number of submissions up to July 2024** is relatively stable (around 200) despite having moved to gold open access;
- 2. **Improving the quality of the selected manuscripts**: the rejection rate is around 90%, which is a strong signal of the seriousness and selectivity of the Editors in choosing high-quality contributions.
- 3. **Diversifying the topics** by publishing contribution in areas as: gender and regional science; cultural heritage at regional level; climate change, natural disasters and regional development;
- 4. The JCR impact factor increases in absolute and relative terms in 2023;
- 5. **Opening new editorial challenge from 2024:** PiRS is now a gold open access journal published by Elsevier; all the archives are also accessible open access.

1. EDITORIAL CHALLENGES

The current Editorial Team of PiRS has been appointed the RSAI council in November 2022. The editorial proposal submitted for consideration in that council developed around a central strategy: consolidate the scientific heritage of the previous Editorial Team but opening the range of interest of the journal given the changing scientific environment in regional science.

The current Editorial Team of Papers in Regional Science (PiRS) will end its term next December 31 2024. During the period 2022-2024 the most important achievements for the journal have been:

- 6. **Increasing the number of submissions:** in 2023 the total number of submissions is approaching almost 500 submissions.
- 7. **Improving the quality of the selected manuscripts**: the rejection rate is around 90%, which is a strong signal of the seriousness and selectivity of the Editors in choosing high-quality contributions.
- 8. **Diversifying the topics** by publishing contribution in areas as: gender and regional science; cultural heritage at regional level; climate change, natural disasters and regional development;
- 9. Increasing the 5-years impact factor JRC and maintaining a leading position in Scopus;
- 10. **Opening new editorial challenge from 2024:** PiRS is now a gold open access journal published by Elsevier; all the archives are also accessible open access.

In the last RSAI meeting (April 2024), the Editor-in-Chief (Rosella Nicolini) has been appointed by the RSAI council for another term (2025-2027). A new development plan and editorial team will be submitted to the last RSAI council in November 2024.

Being consistent with those target the Editorial team in charge of the journal for the period 2022-2024 has been able to gather valuable submissions achieving tangible quantitative results:

1.1. Statistics on the editorial activity

Table 1 presents the number of submissions and rejection rates, together with pending manuscripts, i.e. papers that are in the website system at different stages from 2013 up to present.

In 2022 and 2023, **the number of submissions approached 500** with a rejection rate of around 90% that includes a sizable percentage of desk rejections. In Fall 2023, the Journal moved to the gold open access format and the rate of submission slightly decreased but the percentage of desk rejections dropped impressively. As for the first term in 2024, the Journal got around 200 submissions and 30 of them are under review.

In academic terms, the new format of the journal definitely improved the quality of the submissions.

Despite the increase of the submission, the editorial team was able to keep high productivity standards. We registered **good performance in terms of a decision process reached over the last 7 years** in all phases of the process to publication (Tables 1, 2 and 3). On average, the first decision takes place in less than one month. In addition, the speed of publication after the final decision has improved, reaching less than 3 months (no backlog). It is impressive is that it is now (roughly) half of what it was in 2019. **It is worth mentioning that these results have been achieved despite of the important production delays** experienced with the former publisher (Wiley) and exhacerbated by the transition from the Wiley to the Elsevier platform. At time being, we are still experiencing production issues with Elseviers but we are in permanent contacts of the correspondent officer in order to solve them.

1.2. Salient features of submissions, published articles and reviewers




Figure 1. Geographically detailed number of submissions, 2014–2024 (until July)

Figure 1 presents the geographical distribution of submissions. The trends show a drastic increase of authors from the Pacific area, probably as the result of the high number of Chinese papers submitted. European submissions are therefore no longer the highest, while the Americas' shares remain stable. Interestingly enough, the increase in the total submissions is due to an increase in submission from PRSCO.




Figure 2. Geographic distribution of authors in author pages (% per year and proportion), Vol. 93–103, 2014–2024(until issue 3)

In terms of accepted articles, statistics rebalances in favor of a drop of European scientists and an increase in the scientists from the Americas (Figure 2).

Statistics on reviewers witness that the number of referees keeping being diminishing (the number of desk-rejection increased). The geographical distribution of referees has registered an increase in Europe and in PRSCO area with a decrease in Americas.

All in all, the previous data sources confirm that a clear challenge for the next years would be to still keep on *rebalancing the geographical composition of the authors* and reviewers something that could be connected with the international consolidation and visibility of RSAI. In this respect, given the relevance to consolidate the RSAI reputation – referring to reviewers— the former publisher did not sent out the 2023 Reviewers' certificates and knowing the importance of sending those certificates, we overcame this problem by producing and sending them out directly from the Editorial Office. Also, we reinforced the visibility of published articles in the RSAI official webpage and RSAI newsletter as well as in the social media of ERSA and NARSC. *The expected impact of the marketing strategy for PiRS that Elsevier committed to implement (by including this journal in their major database for scientific dissemination, ScienceDirect) should help to this scope.*




Figure 3. Author pages by affiliation of the author(s), Vol. 93–103, 2014–2024(until issue 3)

In terms of scientific areas, Figure 3 reports the distribution of pages by discipline: economics shrinks a bit whereas geography, public policies and engineering are increasing their share.

Even if the general breakdown in terms of areas keeps relatively stable, in each area, the last numbers and issues of the *journal published innovative and relevant research topics under the lens of the regional science: gender issues, natural disasters and cultural heritage.* It is worth nothing the that 2023 and 2024 Martin Backman award went to two contributions belonging to these new research topics.

2. IMPACT FACTOR

The IF increase from 2.1 in 2022 to 2.4 in 2023. In relative terms PIRS is really close to the Q1 in Economics (72.4 percentile) and it is-de facto- Q1 in Geography (75.1 percentile). Some preliminary hints from the CiteScore Tracker (4.3, in March 2024) make reasonable expectations that PiRS should consolidate its positions in the international rankings. The position of PIRS is relatively stable and moving upward but the target is to reduce the difference with the two direct competitors (JRS and RSUE).




Fig. 4. Citation Impact Factor for various regional science journals, 2013–2023

The last available data for SCIMAGO PiRS confirms its position in the first quartile. In addition,

- 1. The **number of cited documents consolidates around 160**, while non cited ones drop from 65 to 40.
- 2. The total citations grew are stables (around 600). PiRS keeps its position in the best quartile for what concerns both Environmental Science and Social Science (Geography, Planning and Development) with an IF of 0.84.

Since the end of 2022, PiRS has been experiencing huge delays in the production and release of articles and issues due to not well clarified production problems of the Publishers (Wiley, but also Elsevier given that the February issue in 2024 was released end of March 2024). As EiC, I am permanently in contact with the officers in charge of the production and insisting for speeding the release on the online articles. These delays are really harming the number of citations given that the inaccessibility of the articles during the period of reference of the computation of the index reduces the visibility of the scientific contributions published in PiRS. This question has been discussed with the production officer at Elsevier with the explicit request for reverting the situation with no further delay.

The decision to move to a gold open access journal with all the archive free available online will generate a tangible return for the 2024 IF index onward. In addition, the increasing relevance of the underpinning commitments of the CoARA and DORA agreement towards open science practices will call PiRS to implement initiatives to make research material available in peers-to-peers platforms as, for instance, a repository for the databases of the published articles to replicate results.

3 CONCLUDING REMARKS

The action and initiatives implemented by the current Editorial team helped PiRS to consolidate its reputation and visibility in academia and serving RSAI in its dissemination mission.

The most visible achievements are the increase in the number of submissions, the drop of the delay in managing and publishing contributions as well as the opening of new lines of scientific discussion of interest for the scientific communities.

The transformation of the journal from the hybrid to the gold open access format and the changing conditions of the scientific environment moving towards an open science model entail important challenges for the Journal and call for new initiatives to keep being PiRS a point of reference in regional science.

RSPP Editorial Report of 2024

August 2024

Summary*

Along 2024 RSPP received the submission of 115 papers, rejected 52, accepted 10 and 53 are being processed. The impact factor kept same level as 2023 at 1,7 because there was an increase of 25% in the number of papers. Most submissions in 2024 come from Spain, Italy, India, Iran and Indonesia. The RSPP Paper Award 2024 was allocated to two papers: "Using mobile phone data to probe the mobility- related well-being of rural residents: A case study of Chengdu, China", by X Gao, L Liu, D Ou, H Yuwu; and "Urban agglomeration, city size, and spatial density effects on wage flexibility: New evidence on the wage curve in Brazil" by Ana Barufi, Eduardo Haddad and Peter Nijkamp. The Special Issue Award will be allocated by the end of August. Elsevier moved the journal from the area of Geography into the area of Regional and Urban Planning. Emmanouil Tranos, Maria Abreu, Isabelle Nilsson and Patrícia Melo asked to leave the Editorial Team by the end of 2023 after serving the journal for seven years. The Editorial Team promoted workshops in Sarajevo, Samarkanda, Kaisery and Maputo. Since 75% of the papers to be published in 2024 were submitted in 2023, only 10 of the 50 waivers were requested so far. Special Issues will become Special Compiled Issues based on papers of the same topic and editor, published before in the monthly issues.

* Once we receive the Report from Elsevier we can present a full report involving the analysis of the evolution of RSPP along the years.

1. Introduction

This report refers to the activity of Regional Science Policy and Practice from January 2024 to August 2024). In Section 2, we present the journal metrics, in Section 3 presents the activity of the editorial team and in Section 4 concludes.

2. Editorial statistics for 2024

According to Google Scholar, citations on Regional Science Policy and Practice reached more than 1552 in 2022, 1805 in 2023 and 1344 until August 2024. It is expected that in the end of 2024 will reach 2250




Figure 1: Google Scholar RSPP Citations (statistics from August 2024)

According to Scopus (https://www.scopus.com/sourceid/21100435556) the Cite Score was 0.2 in 2015, 0.7 in 2016, 1.0 in 2017, 1.4 in 2018, 0.9 in 2019, 1.4 in 2020, 2.3 in 2021, 3.1 in 2022 and 3.6 in 2023. The drop in 2019 was due to the strong increase in the number of papers from 2018 to 2019. The impact factor kept same level as 2023 at 1,7 because there was an increase of 25% in the number of papers published in the reference period and the citations did not increase more that 25% for the same period. The current CiteScoreTracker for 2024 is 2.7, with 9 issues already published. Hopefully this indicator will recover since it includes 9 months of papers in 2024 and 6 months of citations in 2024.

Focusing on Chengdu Region in China the paper uses mobile phone data to understand rural mobility and the social and orographic factors that influence it. The look into human mobility in remote rural areas, the innovative use of big data and the clear methodological approach allow robust new

evidence on rural mobility and justify adequate policy advises.

Ana Maria Bonomi Barufi, Eduardo Amaral Haddad, Peter Nijkamp (2023), Urban agglomeration, city size, and spatial density effects on wage flexibility: New evidence on the wage curve in Brazil. *Regional Science Policy Practice* 2023 15 (9) Pages 1998-2026. DOI: 10.1111/rsp3.12669

The paper estimates the relation between wages and unemployment considering spatial interaction. Results show the existence of diverse labor markets and concludes that policy makers should be aware of measures to protect formal jobs that, at local level, can increase the wage with informal workers. It is clearly a very good paper able to generate a new common sense on the functioning of labor markets when space is considered.

In 2023, RSPP published 109 papers in 9 issues. The target for 2024 is to publish 120 papers in twelve monthly issues and nine compiled special issues.

The aim is to achieve an Impact Factor of 1,9 in July 2025 in the top of Quartile 2.

Elsevier accomplish to move the journal from the area of Geography into Regional and Urban Planning.

3.4 Editorial Team

Emmanouil Tranos, Maria Abreu, Isabelle Nilsson and Patrícia Melo asked to leave the Editorial Team by the end of 2023.

The editorial team is now composed by Peter Nijkamp, Ana Vinuela, Carlos Azzoni, Katarzyna kkopczewska, Neil Reid, Abdul Shaban, Budy Resosudarmo, Patricio Aroca, Andre Torre, Eveline Van Leeuwen, Gabriela Pascariu, Sumana Banerjee, Jiang Wang, Karima Kourtit, Karina Sass, Louafi Bouzouina, Paul Snow, Samuel Odei, Laura Atuesta, Esteban Fernández, Alfredo Cartone, Vinicius Almeida and Tomaz Ponce Dentinho.

4. Accounts

RSAI in 2024 allocates to RSPP, 6000 Euros for the secretariat and 5000 euros for the editorial team. The 5000 Euros for the editorial team in 2024 went to support RSPP workshops in Sarajevo (April, 2024), Samarkand (May, 2024), Kayseri (May, 2024) and Maputo (June, 2024). 750 Euros are to be allocated for the Special Issue Award.

5. Final remarks

Along 2024 the transference of RSPP from Wiley to Elsevier was accomplished.

Many of the papers published in 2024 were submitted in 2023 corresponding to 9 of the 12 issues planned for 2024. Therefore only 10 waivers were requested so far and there are still 40 to allocate in 2024. Next November an indicative plan to allocate waivers for 2025 will be presented.

With Elsevier, papers are published in monthly issues when they are accepted. Special Issues will be compiled based on papers already published on monthly issues, introduced by the editor of the special issue and with a specific cover photo. Special Issue will become Special Compiled Issues.



Introduction and justification

The organization of the 2026 RSAI World Congress in Quito, Ecuador, is led by the Ecuadorian Regional Science Network (RECiR) and the Department of Quantitative Economics of Escuela Politécnica Nacional. RECIR is an entity that has demonstrated a firm commitment to the advancement and dissemination of knowledge in regional science. It was founded with the purpose of promoting research and collaboration between academics, professionals and politicians interested in regional development, RECIR has positioned itself as a nucleus of scientific and academic activity in Ecuador and the Andean region. The choice of RECiR as organizer of the conference responds to its growing capacity to attract participants, evidenced by its success in previous events and its active participation in international academic networks. Their experience not only guarantees an efficient organization of the congress, but also ensures a program that reflects the most current and relevant topics in the field of regional science. The Department of Quantitative Economics of Escuela Politécnica Nacional has a large trajectory in organizing the International Meeting of Economics, which is a congress organized bi-annually. In 2023, the seventh edition of this congress was organized.

Quito, as the host city, offers multiple advantages that justify its choice. First, its accessibility is remarkable (see Map); Quito, Ecuador's capital city, is served by an international airport that connects directly to the main cities of the Americas such as Miami, Toronto, Atlanta, Mexico, Sao Paulo, Lima, Santiago, among others and has convenient connections to Europe with cities such as Madrid, Amsterdam and Paris and the rest of the world. This facilitates logistics and access for international participants from LARSA, ERSA, NARSC and PRSCO.

Quito International Airport has been awarded the coveted 5-star rating by the British Examiner SKYTRAX, becoming the first in the Americas (North, Central, South America and the Caribbean) to win this 5-star category.





In fact, according to the World Wildlife Fund (WWF), Quito is the most sustainable city in Ecuador. The city has implemented numerous green initiatives and policies to improve the quality of life of its inhabitants and preserve its natural environment. This not only enriches the conference experience, but also provides a practical case study for participants interested in these crucial topics. Quito is a great city for visitors, and the safety is not an issue. Security measures have been implemented at the national level to provide safety. It is then possible to travel to Ecuador. Our airport, maritime ports and roads are operational, with reinforced security measures to ensure the safety of all travellers.

The combination of RECIR as organizer and Quito as host of the RSAI World Congress promises not only an event of high academic and professional level, but also an enriching experience that will leave a lasting legacy for both the participants and the local community.





Objectives of the congress

The RSAI World Congress organized by the Ecuadorian Regional Science Network (RECiR) at the Escuela Politécnica Nacional in Quito, with the central theme "Wellbeing and Sustainability: Regional Science discussions at the Earth's Core" aims to foster a deep and multidisciplinary understanding about how well-being and sustainability are crucial for regional development. This broad theme involves topics covering regional and urban economics, entrepreneurship, innovation, Artificial intelligence challenges for regional development, governance, regional networks and social inclusion.

The specific objectives of the congress will be:

a. Multidisciplinary Approach of Wellbeing and Sustainability:

The conference will seek to address these issues from various disciplines, including economics, geography, politics, environmental sciences and public health, to provide a comprehensive understanding of the challenges and solutions in regional contexts. It will explore how human well-being and environmental sustainability interconnect and impact regional planning and development.

b. Promotion of Innovative Research:

To encourage the presentation and discussion of research that provides new perspectives and innovative solutions for the improvement of community well-being and sustainable resource management in different regions. The conference will serve as a platform for emerging and established researchers to present their work, thereby promoting academic exchange and collaboration.

c. Integration of Sustainable Practices in Regional Planning:

To discuss how sustainable practices can be integrated into regional planning and management, with a focus on policies that promote a balance between economic growth and environmental conservation. This will include sessions on sustainable urbanism, renewable energy, waste management and biodiversity conservation in urban and rural contexts.

d. Promotion of Social Welfare through Public Policies:

To analyze the role of public policies in promoting social well-being and resilience, especially in disadvantaged regions. Approaches that address

inequality, access to basic services, education and health will be considered as foundations for equitable regional development.

- e. Strengthening Regional Resilience in the Face of Global Changes: It will focus on how regions can strengthen their resilience to global challenges such as climate change, pandemics and economic crises. The idea is to explore regional strategies that can absorb impacts, adapt and positively transform in the face of such challenges.
- f. International Collaboration and Knowledge Transfer:

To promote collaboration between regions and countries for the exchange of knowledge and best practices on well-being and sustainability issues. This includes strengthening networks between academics, practitioners, and policy makers, thus facilitating international cooperation on regional projects and policies.

Tentative program

To offer an attractive program of interest to the global scientific community, we plan to include academic, networking and workshop activities. For keynote speeches, we plan to invite some world-famous scientists (e.g. Carlos Moreno and a Nobel Lauréate-still to be confirmed). Plenary sessions discussing topics of interest are planned.

Dedicated sessions for young scholars are also included ('meet the professor') in the program. These sessions will be co-organized with the Chilean Society of Regional Studies SOCHER (Chilean RSAI section) and will offer a short training on cutting-edge regional science and the possibility to exchange more closely with expert professors in the field. To do so, we are going to apply for RSAI funds regarding the "Nurturing New Talent" program. This short training is intended to continue be nurtured over time to develop a certification with a rotating basis in country RSAI sections, mainly from Latin America Regional Science Association LARSA.

To ensure the academic quality of the program, a strong scientific committee will be made up of scientists from different research institutions around the world.

The proposed dates for the 2026 RSAI World Congress are: **May 25th to 28th**, 2026. However, as indicated Quito accounts for a remarkably good weather throughout the year, so these dates are open to negotiating with RSAI and other supranational sections.

A tentative program structure for the RSAI World Congress in Quito under the theme "Wellbeing and Sustainability: Regional Science discussions at the Earth's Core", organized by the Ecuadorian Regional Science Network (RECiR) at Escuela Politécnica Nacional, is detailed below.


The logistics planning for organizing the RSAI World Congress in Quito, Ecuador is detailed below:

a) Place

The congress will take place at the university Escuela Politécnica Nacional, a modern and versatile space located in the center of Quito. This university is known for its ability to host large international events, with multiple auditoriums, rooms and classrooms that can be configured according to the specific needs of the conference. In addition, it is equipped with the latest technology in audiovisuals and internet connectivity.

















b) Accommodation

Quito offers a variety of accommodation options ranging from luxury hotels to more affordable options. For the congress, special rates will be negotiated with hotels near the university, such as the Hotel Quito and Hotel Fenix. In addition, through the collaboration of sponsors such as Young Scholar Initiative (YSI), travel grants will be available for a number of participants with a limited budget.

h) Proceedings of the conference

The proceedings of the conference will be published with ISBN using the RSAI platform.

e) Risk assessment

As every event, this event could have some problems that could arise before, during and after it. Before the congress, we could face risks such as interruption in the supply of supplies for the conference. To mitigate this risk, we are going to hire a company specialized in organization of academic events. Other risk that we could have is a failure in operating equipment. To mitigate this issue, we are going to get a video conferencing system. Security for participants is ensured since to enter the university, there are permanent guards in all access entries. All of them will be informed timely about the conference and its participants. In case of a failure in the electricity provision, the conference venue is planned to take place in a building with independent electric generation plant. We also account for the support of a neighboring university (PUCE) in case of any problem in the facilities of EPN.
