RSAI COUNCIL MEETING APRIL 2024 / MINUTES

1. Apologies (Annex 1)

No member has sent prior warning of her/his absence.

At 1.05 pm local time, the President, Prof. Westlund, opens the meeting. This is attended on site by Carlos Azzoni (LARSA representative), Hiroyuki Shibusawa (RSAI Vice President), Andrea Caragliu (RSAI Executive Director), Hans Westlund (RSAI President), Elisabete Martins (RSAI secretariat and financial officer), Tomaz Dentinho (at-large), Roberta Capello (ERSA President and representative), Camilla Lenzi (at large), Kathy Kopchewska (at-large), André Chagas (at-large), and Daniela Constantin (atlarge). The meeting is also attended online by Fernando Perobelli (LARSA representative), Lise Bourdeau-LePage (ERSA representative), Eveline Van Leeuwen (ERSA representative), Rosella Nicolini (PiRS EiC), Sandy dall'Erba (NARSC representative), Hidehiko Kanegae (PRSCO representative), and Haifeng Qian (NARSC representative).

2. Approval of the minutes of the Alicante meeting (Aug. 31, 2023; Annex 2)

Hans Westlund proposes to approve the minutes, as no comment on the draft circulated before the meeting was received. The proposal is unanimously accepted, and the minutes are approved.

3. Updates on the World Congress 2024 (Andrea Caragliu)

Andrea Caragliu reports on the congress. Several abstracts were received, with delegates from 41 Countries and 283 paper abstracts received and accepted. The congress is benefitting from an extraordinary support from the LOC, whom the RSAI Council praises for their effort.

4. Important decisions for 2024:

a. Transition to the new President (Prof. Shibusawa, PRSCO)

Hans Westlund welcomes Hiroyuki Shibusawa, Camilla Lenzi, Kathy, André Chagas, and Roberta Capello, as new members of the council. He also welcomes Prof. Shibusawa specifically for his new role as RSAI Vice President. Prof. Shibusawa says he is honored by his new position, and guarantees the Council an effort to keep the good momentum of the Association.

End of first term for PiRS's EiC (report by Rosella Nicolini, Annex 3)

Andrea Caragliu explains that this is the end of the first term for Prof. Nicolini as EiC of Pirs, and he summarizes his personal positive opinion of her work, which Hans Westlund also reports was shared by the LRPC members during the meeting held the day before this council gathered. Prof. Caragliu explains that the EiC can be chosen based on a public call, or a direct appointment. Rosella Nicolini explains what her view the state of the journal is, and draws her attention on the challenge in the transition of both RSAI journals to gold open access. Daniela Constantin (PiRS co-editor) praises Rosella Nicolini for her job.

Roberta Capello suggests to vote now on her re-appointment. Hans Westlund asks if anybody has anything against this decision; the Council agrees to vote immediately for the potential appointment of the EiC of PiRS. Prof. Nicolini is asked to leave the online room for allowing voting. The Council unanimously vote to confirm Prof. Nicolini as PiRS EiC for a second term, running from 2025 through 2027. Andrea Caragliu invites Prof. Nicolini back to the online meeting, and the Council congratulates

Rosella on being reappointed. Prof. Nicolini thanks the council for the trust in her work, and reassures she will strive to keep the journal on the growth path.

c. End of the Executive Director's second term. Opening for a new ED due August 2024.

Andrea Caragliu explains that the Council is seeking for an orderly, hard-working, and, ideally, good with relations candidate. Roberta Capello proposes to nominate a committee, with Hiroyuki Shibusawa, Andrea Caragliu and other members. Daniela Constantin advises to seek somebody with prior experiences. In this view, Carlos Azzoni suggests to include Tomaz Dentinho in the committee. Hans Westlund closes suggesting Hiroyuki Shibusawa, Andrea Caragliu, Tomaz Dentinho, and Eveline Van Leeuwen to join the committee. Carlos Azzoni suggests to be in touch with supranational organizations to include as diverse candidates as possible. The Council approves and the Search committee will be operative right away, with a tentative deadline for applications around late June/early July.

d. Fixing things before the end of the second term: revising By-Laws to update them to changes in supranationals.

Andrea Caragliu refers there is a number of minor changes to be included in by laws, which can by RSAI Constitution be amended with the approval of the majority of the Council. He will suggest fixes to these by-laws before the end of his term as RSAI ED, so that his successor will find everything as in order as possible.

5. Reactivating the committee in charge of restructuring PRSCO

Andrea Caragliu reminds the council that a committee specifically dedicated to restructuring PRSCO< due to its now rather large extension, originally included the RSAI president (by then, Prof. Partridge); Prof. Budy Resosudarmo; Prof. Rachel Franklin (by then, PRSCO President); Prof. Yoshiro Higano (JRSAI); Prof. Sumona Bandyopadhay (representing Indian RSAI); Prof. Paul Snow (for RSAC); Prof. Brian Kim (representing KRSA); and Prof. Kingsley Haynes, representing the LRPC). Following a similar structure, Prof. Caragliu suggests to include Hidehiko Kanegae, Paul Snow, Sumona Bandyopadhay, Brian Kim, Budy Resosudarmo, and Kingsley Haynes. Prof. Kanegae suggests to include In Kwon Park, as new PRSCO President, and of course Prof. Shibusawa as new RSAI President. The proposal is approved, and the committee in charge of dealing with restructuring PRSCO will be made of Paul Snow (RSAC), Sumona Bandyopadhay (India), In Kwon Park (KRSA and PRSCO), Budy Resosudarmo and Kingsley Haynes (LRPC), and Hiroyuki Skibusawa (RSAI President).

6. Report on the activities of the Honors, Diversity and Inclusion, and Communications Committees (Hans Westlund)

Hans Westlund summarizes the issues with the committees, whose work has been intermittent and only based on frequent nudging. Kathy Kopchewska asks to summarize the events. Tomaz Dentinho proposes to bring back these mandates. Andrea Caragliu summarizes the sequence of the events as requested. Roberta Capello suggests that as suggested by the LRPC the Council should replace the candidates, and she advises that Hans Westlund and Andrea Caragliu are tasked with the goal of identifying suitable replacements. Eveline Van Leeuwen suggests that marketing of these committees' is started. Tomaz Dentinho advises to set up committees made up of council members. Sandy dall'Erba reminds the Council about his experience with the NARSC Diversity and Inclusion committee. He concludes that we need to find a way so that the D&I committee communicates with all other committees.

7. Call for candidatures for organizing the World Congress 2026

Hans Westlund asks Andrea Caragliu to summarize. André Chagas says that some Countries in LARSA would be interested, mentioning that Carolina Guevara (newly elected president of the Ecuador

section) would be glad to propose one. The Brazilian and Chilean sections would promote this candidature. He also add that a generational transition would be enhanced if the World Congress 2026 would be organized there. Andrea Caragliu concludes letting the Council know that a public call for applications to organize the 2026 world congress of the RSAI will be released at the beginning of May, with deadline around early July.

8. Proposal to anticipate the schedule of the RSPP Special Issue Award from September to August (Tomaz Dentinho)

Prof. Dentinho describes is proposal, which the Council unanimously approves.

9. Report on RSPP (Tomaz Dentinho, Annex 4)

Tomaz Dentinho explains the content of the report. The Council praises Prof. Dentinho for his good wok on the journal.

10. RSPP Paper award (Tomaz Dentinho, Annex 5)

Prof. Dentinho explains the contents of the attachment. The Council thanks him for his work.

11. Reshuffling of RSPP editorial board (Tomaz Dentinho, Annex 6)

Christa Court and Soomi Lee (NARSC), and Carolina Guevara (LARSA). He proposes to invite Taiwanese colleagues to promote a special issue on RSPP.

12. AOB

No other business is suggested.

13. Next meeting

With nothing else to discuss, the President closes the meeting at 2.12 pm local time. The next meeting will take place in Terceira during the ERSA Congress.

End-of-Term Report

Summary

The current editorial team of *Papers in Regional Science* (*PiRS*) will end its current term on December 31, 2024. From 2022 to 2024, the most important achievements for the journal have been:

- 1. **Increasing the number of submissions:** In 2023, the total number of submissions to *PiRS* approached nearly 500.
- 2. **Improving the quality of selected manuscripts:** The journal's rejection rate is approximately 90%, which signifies the editors' rigor and selectivity in choosing high-quality contributions for publication.
- 3. **Diversifying topics addressed:** By publishing contributions on topics such as gender and regional science, cultural heritage at the regional level, and climate change, natural disasters, and regional development, *PiRS* has expanded the range of its content.
- 4. **Strengthening impact:** *PiRS* has increased its 5-year impact factor (JRC) but also maintained a leading position in Scopus.
- 5. **Embarking on a new editorial challenge:** As of 2024, *PiRS* is now a gold open-access journal published by Elsevier, with open-access archives as well.

1. EDITORIAL CHALLENGES

The current editorial team of *PiRS* was appointed by the RSAI Council in November 2022. The editorial proposal submitted for consideration by the Council developed around the central strategy of consolidating the scientific legacy of the previous editorial team while expanding the journal's range of interests given the shifting environment in regional science.

Consistent with those targets, the editorial team in charge of the journal from 2022 to 2024 has been able to gather valuable submissions that have helped to achieve tangible quantitative results, as detailed in the following.

1.1. Statistics regarding editorial activity

Table 1 presents the number of submissions and rejection rates, together with the number of pending manuscripts (i.e., papers in the online system), at different stages from 2010 to the present.

In 2022 and 2023, *the number of submissions to PiRS approached 500*, with a rejection rate of approximately 90% that included a sizable percentage of desk rejections. In fall 2023, the journal moved to gold open-access format, and whereas the rate of submissions decreased only slightly, the percentage of desk rejections dropped significantly. In the first term of 2024, the journal received approximately 100 submissions, 30 of which are currently under review. From an academic standpoint, the new format of the journal has clearly improved the quality of submissions.

Despite the increase in submissions, the editorial team was able to keep high standards for productivity. The journal registered good performance in its rendering of decisions regarding manuscripts in the past 7 years in all phases of the publication process (see Table 2). On average, the first decision has taken place in less than a month. In addition, the speed of publication after the final decision has fallen to less than 3 months compared to twice that much in 2019, such that no backlog exists. Moreover, those results have been achieved despite major delays in production experienced with the former publisher, Wiley, and exacerbated by the journal's transition to Elsevier's platform.

1.2. Salient features of submissions, published articles, and reviewers




Figure 1. Geographically detailed number of submissions, 2010–2023

Figure 1 presents the geographical distribution of submissions to *PiRS*. The trends show a drastic increase of authors from the Pacific region, probably due to the high number of papers submitted by authors in China. Submissions from Europe are no longer dominant, whereas the share of submissions from the Americas has remained stable. The increase in the total number submissions is also likely due to an increase in submissions from PRSCO.




Figure 2. Geographic distribution of authors in pages (% per year and proportion), volumes 89–102, 2010–2023

In terms of accepted articles, statistics have rebalanced in favor of authors from Europe (see Figure 2).

In the same wake, statistics regarding reviewers confirm previous trends. The number of referees has continued to diminish as the number of desk rejections has increased. Moreover, the geographical distribution of referees has registered an increase in Europe and a decrease in Americas, whereas the rate from PRSCO has remained rather stable.

In all, the data confirm that a clear challenge for PiRS in the coming years will be rebalancing the geographical composition of authors and reviewers, possibly in connection with the international consolidation and visibility of the RSAI. In that respect, given the relevance of consolidating the RSAI's reputation as indicated by reviewers, the former publisher did not issue reviewers' certificates for 2023; however, recognizing the importance of issuing those certificates, PiRS overcame the problem by producing and sending them out directly from the Editorial Office. The visibility of published articles on the RSAI's official webpage and in its newsletter as well as in ERSA's and NARSC's social media was also reinforced. The expected impact of the marketing strategy for PiRS that Elsevier committed to implement (i.e., by including the journal in its major database for scientific dissemination, ScienceDirect) should help to reach that scope.




Figure 3. Number of pages by affiliation of the author(s), volumes 89–102, 2010–2023

In terms of scientific areas, Figure 3 reports the distribution of pages by discipline. Whereas the share for economics has shrunk slightly, the shares for geography, public policy, and engineering have increased.

Even if the general breakdown in scientific areas has remained relatively stable, in each area the last issues of the journal have published innovative, relevant topics in research from the lens of regional science, including topics such as gender issues, natural disasters, and cultural heritage. In 2023 and 2024, the Martin Backman Award went to two contributions addressing those new topics.

2. IMPACT FACTOR

PiRS currently awaits the release of statistics from 2023 concerning impact factor (IF). Nevertheless, some early hints from CiteScore Tracker (4.3, in March 2024) suggest that *PiRS* should have consolidated its position in international rankings. The most recent data from Scimago confirm *PiRS*'s position in the first quartile. In addition:

- 1. The **number of cited documents** has been approximately 190, whereas the number of non-cited ones has dropped from 66 to 63; and
- 2. Total citations has grown from 742 to 750, whereas the per-document citation rate remained stable at approximately 3. PiRS has maintained its position in the first quartile regarding content concerning both environmental science and social science (e.g., geography, planning, and development) with an IF of 0.86.

PiRS's IF in 2022 according to Clarivate was approximately 2.1, the same as the IF for 2021, after experiencing a major drop in the value of the index for 2021 with respect to 2020. In relative terms, the performance of *PIRS*'s direct competitors is relatively stable apart from *RSUE*, a journal currently published by Elsevier that has experienced a remarkable increase in IF.

Since the end of 2022, PiRS has experienced massive delays in the production and release of articles and issues due to poorly clarified problems with the publishers—not only Wiley but also Elsevier, given that the February issue in 2024 was released at the end of March 2024. As editor in chief, I am continually in contact with the officers in charge of the production and have insisted upon accelerating the release of online articles. The delays are significantly harming the number of citations received because the inaccessibility of articles during the reference period for the computation of the index reduces the visibility of scientific contributions published in PiRS. That dilemma has been discussed with the production officer at Elsevier and an explicit request made to rectify the situation immediately.

The decision to becoming a gold, open-access journal with all archives freely available online will generate a tangible return for PiRS's IF in 2024 and years to come. Beyond that, the increased relevance of the commitments of the CoARA and DORA agreements toward open

science practices will call *PiRS* to implement initiatives to make research material available in peer-to-peer platforms as in, for instance, a repository of databases linked to published articles for researchers to use to replicate results.

3 CONCLUDING REMARKS

The action and initiatives implemented by *PiRS*'s current editorial team have helped the journal to consolidate its reputation and visibility in academia and to serve the RSAI in its dissemination mission.

The *most visible achievements* have been the increased number of submissions, the shortened delays in managing and publishing contributions, and the opening of new lines of scientific inquiry in new scientific communities.

PiRS's transformation from hybrid to gold open-access format and the changing conditions of the scientific environment amid growing acceptance of an open science model pose important challenges for the journal and call for new initiatives to continue making *PiRS* a point of reference in regional science.

RSPP Editorial Report of 2023

April 2024

1. Introduction

This report refers to 2023 when Regional Science Policy and Practice is editing 9 issues (see Annex 2). In Section 2, we analyze the journal metrics, in Section 3 we highlight the aims and actions of the editorial team and in Section 4 we conclude.

2. Editorial statistics

2.1 Pages, Papers and Citations

The number of articles and citations per year increased from 2017 - with 11 published articles and 41 citations to 2023 - with 119 articles and 1319 citations.




Figure 1: Citations per Year (RSPP Editorial Office)

The geographical distribution of the authors, counted by the number of articles, indicate a good distribution of the authors in all the world with a minor presence in Africa and a major contribution from United States, Italy, Russia, Hungary, Spain, Portugal, Brazil, Morocco, Indonesia, and India.




Figure 2: Geographical distribution of authors by articles (Wiley Journal Insights)

The disciplinary distribution of the authors' affiliation measured by the number of pages is mainly concentrated in economics and geography, giving space to interdisciplinary perspectives.




Figure 3: Downloads by Country (Wiley Journal Insights)

On the other hand, the number of downloads is quite spread around the world although more intense in the United States of America, the United Kingdom and China.

2.2 Decision making process




Figure 5: Accepted and rejected articles (decision by decision year)




Figure 6: Accepted and rejected articles (decision by submission year)

2.3 Performance Indicators

According to Google Scholar, citations on Regional Science Policy and Practice reached more than 1117 in 2021, 1538 in 2022 and 1777 in 2023.




Figure 7: Google Scholar RSPP Citations (statistics from April 2024)

According to Scopus (https://www.scopus.com/sourceid/21100435556) the Cite Score was 0.2 in 2015, 0.7 in 2016, 1.0 in 2017, 1.4 in 2018, 0.9 in 2019, 1.4 in 2020, 2.3 in 2021 and 3.1 in 2022. The drop in 2019 was due to the strong increase in the number of papers from 2018 to 2019. The current CiteScoreTracker for 2023 is 3.6.



Figure 8: Scopus Cite score of RSPP




Figure 9: Downloads and Citations (Wiley Journal Insights)

4. Expected and achieved results

In 2023, RSPP published 119 papers in 9 issues. The target for 2024 is to publish 120 papers in twelve or more special issues. The aim is to achieve an Impact Factor of 1,9 in July 2024 in the top of Quartile 2 on Geography or the lower part of Quartile 1.

5. Accounts

RSAI in 2023 allocates to RSPP, 6000 Euros for the secretariat and 5000 euros for the editorial team. The 5000 Euros for the editorial team in 2023 went to support RSPP workshops in Sarajevo (March 2024), Samarkand (May, 2024); Kayseri (May, 2024); Maputo (June, 2023), and Yerevan (October, 2024).

6. Concluding remarks

In the year 2023 we have succeeded in increasing the number of submissions and issues as well as in reaching recognition by the ISI Web of Knowledge with an Impact Factor of 1,7.

For 2024 we expect to achieve an Impact Factor of 1,9 in July 2024 in the top of Quartile 2 on Geography or the lower part of Quartile 1.

The Open Access creates a major challenge to allow all good papers to be published independently of the capacity of the authors to pay the APCs. It also puts RSPP in the "public eye" reinforcing its role to publish robust and sound scientific evidence to promote the sustainable development of people and places.




