NECROLOGY PROFESSOR MOSS MADDEN 1946 - 2000

Professor Moss Madden, a long-standing member of RSAI and the immediate past Chairman of the British and Irish Section, died suddenly on 16 February at the age of 53. It was typical of Moss's commitment to participation in international regional science activities that, at the time of his tragic death, he had only recently returned from the South African Symposium on Regional Development in Port Elizabeth, was on the point of leaving to join the Anglo-Irish/Israeli Workshop that he had done so much to coorganise in Jerusalem, and two weeks later was due to present a paper at the Western Regional Science Association meeting in Hawaii.

Moss was brought up and went to school in Falmouth and retained his Cornish roots. He took great pleasure in organising the 1997 Annual Conference of the British and Irish Section in Falmouth, a venue that was much appreciated by those that attended. He spent the whole of his academic career at the University of Liverpool, first as a student of engineering and then as a staff member of the Department of Civic Design. He was appointed to a Chair in Planning and Regional Science in 1993.

Moss first came to appreciate the benefits of presenting his ideas and research output before an international regional science audience at the European RSA Congress in London in 1979. After that first taste of the conference circuit, Moss soon became a regular participant in RSAI conferences and workshops both in Europe and in North America, following his attendance of the First World Congress in Regional Science in Boston in 1980.

Moss also soon became involved in the development of the activities of the then British Section of the RSA, joining the committee in 1982. His early contributions included involvement in the organisation of the European

Workshops on Strategic Planning and later the establishment, in 1990, of the UK Inter-Regional Input-Output Table Workshop and its subsequent convenorship. However, it was in the establishment of the Anglo-Israeli Regional Science Workshops series, initiated in 1991 in collaboration with Dani Shefer, that Moss made a major contribution to the development of international networks of regional science research co-operation.

Moss's increasingly influential role in the British Section was reflected in his election as Section Chairman between 1993 and 1997. It was in this capacity that Moss was largely responsible for the renaming of the Section as the British and Irish Section and was the leading force in initiating the Section's hosting of the European RSA Congress in Dublin in 1999.

These events provided a fertile environment in which to cultivate his research contributions and to establish and foster his collaborative links. These mainly focused upon furthering the development of innovative new approaches to the handling of interactions between demographic and economic elements of the traditional input-output modelling framework that he mapped out and explored in particular with Peter Batey. There were perhaps, two underlying principles that underpinned much of his research. First, he believed that the focus of research should be to understand and lead towards the solving of real problems and that theory by itself was not sufficient - it had to be applicable. Second, although he concentrated on applied work, he was always eager to introduce and develop new techniques in his

analyses. He recognised that policy choices could be best informed by a careful application of the latest theoretical developments to real world problems.

Not only did Moss demonstrate his own abilities in this area; he also encouraged others to demonstrate theirs'. At meetings he was keen to engage in academic debate with others. He was always ready to help to convene sessions at conferences in order to bring together scholars, often with quite differing backgrounds to exchange ideas on a given topic. His wide range of interests and contacts made him the ideal person for this. He also recognised the importance of disseminating the ideas raised at such sessions to a wider audience as is evidenced by the number of edited volumes he collated and contributed to. It is appropriate that a lasting testament to Moss's contribution to the field of regional science will be his many individually authored and collaborative publications - not least those volumes to which he devoted so much time and effort in helping to organise and subsequently to co-edit. To the earlier individual volumes coedited with Peter Batey, Luc Anselin and Geoff Hewings, has recently been added 'Regional Science in Business', coedited with Graham Clarke - with further volumes close to completion at the time of his death.

Moss's outstanding work in the fields of planning and regional science was recognised last year with his election as one of the founding Academicians of the Association of Learned Societies for the Social Sciences.

There can be no doubt that those of us who were privileged to know him will continue to recall and appreciate the many ways in which Moss's presence made involvement in the organisation and attendance of regional science events, and associated activities, all the more rewarding and enjoyable. We can count ourselves fortunate that we were able to benefit from his infectious enthusiasm for his subject, his illuminating grasp of technical detail, his incisive questioning from the chair or the floor and, perhaps above all, from his humour, wit and wholehearted commitment to engaging in, and enjoying, the social interaction and networking upon which the healthy future development of the regional science community will continue to depend. The world of regional science, to which he made so many valuable contributions, will be so much the poorer for his passing.

NEW JOURNAL

The 1990s have seen an important geographical turn in economics, evidenced most notably by the emergence of a major research field, the 'new economic geography', whose subject matter includes spatial agglomeration economies, increasing returns, path dependence, regional growth convergence, and imperfect competition. In geography, meanwhile, a new generation of scholars has sought to extend the scope and significance of 'economic geography' to consider some of the most important issues of contempo-

rary economic life, including globalization, the growth and decline of cities and regions, innovation and the restructuring of economic systems. Differences remain between geographers and economists over the method and scope of 'economic geography', including what *The Economist* (March 13, 1999) contrasted as 'bottom-up versus top-down' approaches to explanation. Nevertheless, the field is growing and vibrant, and has increasingly come to be seen as both a crucial area of innovation in the social sciences, and a reference point in the debates about the processes of global economic change and the future of cities and regions over the coming century.

The Journal of Economic Geography has been founded with the goal to redefine and reinvigorate the intersection between economics and geography, to catalyze the 'meeting of minds' between the disciplines urged by *The Economist*, and to provide a world-class core journal in the field for the new millennium. To be published on a quarterly basis, the journal will be steered by a distinguished Editorial team and Editorial Board drawn equally from the two disciplines. It will seek to publish original academic research and discussion of the highest scholarly standard in the field of 'economic geography' broadly defined. Submitted papers will be refereed, and will be evaluated on the basis of their creativity, quality of scholarship, and contribution to advancing understanding of the geographic nature of economic systems and global economic change.

MICHAEL GREENWALD, UNIVERSITY OF CALIFORNIA, IRVINE, NAMED TO RECEIVE FIRST ANNUAL BENJAMIN H. STEVENS GRADUATE FELLOWSHIP IN REGIONAL SCIENCE

Michael J. Greenwald, doctoral student in the Department of Urban and Regional Planning at the University of California, Irvine, has been selected as the winner of the competition for the first annual Benjamin H. Stevens Graduate Fellowship in Regional Science. The Fellowship will provide a \$15,000 one-year stipend to support Greenwald in his dissertation research on how land use and urban form regulation influence travel mode choices for households in

the Portland, Oregon urban area. The dissertation is titled: "The Road Less Traveled: Land Use and Non-Work Travel Relationships in Portland Oregon." Professor Marlon G. Boarnet of U.C. Irvine's Departments of Urban and Regional Planning and Economics is the dissertation supervisor. The Fellowship is awarded in memory of Dr. Benjamin H. Stevens, an intellectual leader whose selfless devotion to graduate students as teacher, advisor, mentor, and friend had a profound impact on the field of regional science. PUBLIC INVESTMENT AND REGIONAL ECONOMIC DEVELOPMENT; 3RD ISRAELI - BRITISH & IRISH JOINT REGIONAL SCIENCE WORKSHOP, HELD AT HEBREW UNIVERSITY OF JERUSALEM, 14-16 FEBRUARY, 2000.

This meeting was the third in a series of joint regional science workshops that the Israeli and British and Irish sections have been conducting over the years. Held on the Mount Scopus campus of the Hebrew University of Jerusalem, the meeting included over twenty papers presented in two intensive days of sessions and a third day dedicated to touring of the Dead Sea area. Topics addressed included public investment and regional economic development in areas such as industrial innovation, infrastructure and environment, human capital and employment creation. The workshop dinner featured a special presentation made by Dani Shefer and John Parr to Stan Czamanski in recognition of his contribution to the field of regional science.

Moss Madden's presence at the workshop was sorely missed. As one of the initiators of this series of meetings, he had intended to present a paper and had been very instrumental in putting together the British & Irish delegation. A volume of selected papers presented is to be published as a fitting tribute to his memory.

TURKISH NATIONAL COMMITTEE OF REGIONAL SCIENCE, ISTANBUL TECHNICAL UNIVERSITY, JULY 2-8, 2000

Turkish National Committee of Regional Science is currently organising the Thirteenth European Advanced Studies Institute in Regional Science.

The preceding Advanced Studies Institutes were held at The University of Karlsruhe in 1970, 1972 and 1974, at The University of Siegen in 1978, The Free University of Amsterdam in 1980, The University of Bamberg in 1984, The University of Milan in 1988, The University of Joensu in 1991, The University of Athens in 1995, The Norwegian Institute of Urban and Regional Research, Oslo at Are and

Meraker in 1997, The University of The Federal Armed Forces at Munich in 1998, The University of Algarve at Faro in 1999. It was decided to continue them by the European Regional Science Association Council. Advanced Studies Institute, Regional Science Summer Institute will be hosted by The Istanbul Technical University in 2000.

Aims for the Summer Institute 2000

It is argued that expansion and integration processes in Europe are interacted with spatial changes. In this way, some areas become more developed when some of them become less developed. Meanwhile, some stand-by issues could appear for peripherial and cross border regions. In this connection, it should be worthwhile to discuss expansion processes in order to evaluate positive and negative effects of the efforts for a more balanced spatial pattern and interpret certain projects for the infrastructure development.

Institute Programme

The Institute programme consists of lectures, workshops and a Round Table. Lectures 90 minutes each will provide top level presentations of major aspects involved in the Programme. They should be attended by all participants.

Each workshop will be arranged for one week duration. Workshop sessions - scheduled for 90 minutes daily - will be devoted to creative discussion and group work among the participants of specific questions related to the planned topics of the workshop. The positions of workshop leaders will be assigned to members of the Institute's staff. Final workshop reports will be presented to the Institute Assembly.

Lecturers and workshop leaders will cover internationally renowned scholars. As visiting speakers, high ranking European Union and government officials from Eastern and Western countries are expected.

A Round Table will be arranged on the topic "Regional Policies Facing the Expansion of the European Union", for discussion on the focus of possibilities and limitations of urban and regional planning on a cross border perspective. For further information please contact:
