## *Save the Date for Our 59<sup>th</sup> Annual Meeting!*

March 18-21, 2020*

Aloha! It's that time again! WRSA will be heading to Honolulu, Hawaii for the 59<sup>th</sup> annual meeting. For the first time in 37 years we will be going back to the island of O'ahu. We will be meeting March 18-21, which is a little later in the year than our usual February dates. Hopefully that means the rainy season will have passed! This year will be a joint meeting, as we will be co-hosting the 26<sup>th</sup> Pacific Conference of the RSAI with the Pacific Regional Science Conference Organization (PRSCO).

It's never too soon to get the next annual meeting on your calendar. The Honolulu meeting will open on Wednesday, March 18<sup>th</sup> with the Lay James Gibson Opening Plenary Session and the Welcoming Reception. Three days of paper sessions and social events will follow on Thursday, Friday, and Saturday (the 19<sup>th</sup> through the 21<sup>st</sup>).

## Napa Valley

### 58<sup>th</sup> Annual Meeting Highlights

California's wine country proved to be a great host for us this year! Napa lived up to its reputation even if the weather was a little uncooperative. The meeting was, as usual, fantastic showcasing thoughtful sessions, lively discussion, and ample opportunity to connect with colleagues and old friends. It wasn't all work though, in keeping with the theme of our host city, this year's meeting also included a blind wine tasting competition. A special thanks to WRSA's own Pete Parcells for putting that together! Out of the seventy participants only two were able to correctly pair the five wines to their descriptions. Congratulations to Brian H.S. Kim and Donghwan An for demonstrating their oenological erudition (or sheer luck).

In terms of size, this year's meeting had a good turn-out: 155 attendees from 16 different countries. Other than the 93 participants from the U.S., Korea, Sweden and Japan had the next largest representation with 17, 9, and 8 attendees, respectively. The meeting program included 32 different paper and panel discussions, including the traditional Remote Regions session, AUBER's Western States Economic Outlook panel, and TRSA (The Regional Science Academy) workshops and sessions.

This year's plenary sessions were outstanding. The 9<sup>th</sup> Annual Lay James Gibson Opening Session provided another auspicious start to our annual meeting. Ralph McLaughlin, the Deputy Chief Economist at CoreLogic was the guest speaker. He gave an engaging presentation on "Automated Transport, Regional Economies, and Land Use."

The 7<sup>th</sup> Annual Getis-Ord Lecture in Spatial Analysis was delivered by the renowned Michael Batty from University College London. Dr. Batty spoke on "Extending Spatial Systems to Embrace Hierarchies of

Interaction." His discussant was Peter Batey from the University of Liverpool.

This year's meeting kept up the tradition of providing an enjoyable social program, which included the Annual Banquet Luncheon, The Getis-Ord Lecture Reception, as well as the Welcoming and President's Receptions. The Annual Banquet Luncheon was highlighted by Genevieve Giuliano's thoughtful Presidential Address on the topic of "Agglomeration Economies and Evolving Urban Form."

The luncheon also showcased student success with the winners of the Tiebout Prize and Springer Prize being awarded.

## Chad Christenson Wins Tiebout Prize

At this year's conference, the 33<sup>rd</sup> Tiebout Prize was awarded to Chad Christenson, a doctoral student from the University of Wisconsin-Madison. Christenson's winning paper was titled, "*Do Factors Contributing to Appearance and Success of Conservation Referenda in the West Differ from Those Found in Other Regions?*" Congratulations Chad!

The Tiebout Reading Committee, comprised of past WRSA Presidents, is charged each year with evaluating a large pool of submissions. This year's committee included: David Plane from the University of Arizona, Alan Murray from the University of California, Santa Barbara, Bruce Newbold from McMaster University, and Sergio Rey from the University of California, Riverside.



This year the Tiebout Prize Reading Committee also selected two papers for Honorable Mentions. These were Karelys Guzman from the University of Illinois, Champaign-Urbana and Min Xiong from Florida International University.

The Tiebout Prize is given in memory of Charles Tiebout and his contributions to regional science, especially his mentoring of graduate students. Due to an unprecedented donation to the Tiebout Fund (see story below), winners of future Prizes will receive \$1,250 to help defray the costs associated with attending the annual meeting.

## **Tiebout Prize Historic Donation**

As with most prize funds, the Tiebout Prize relies on donations to sustain the endowment that pays out the annual prize. This year, thanks to the generosity of Art Getis—longtime WRSA member, past president, and founder of the WRSA Annual Getis-Ord Lecture—the Tiebout endowment received a gift large enough to allow us to increase the size of the award the winner receives, from \$1,000 to \$1,250. ## **Springer Prize Winner Goes to Sutee Anantsuksomsri**

Each year a prize is given at the annual meeting for the best paper presented at the conference by a young career scholar (PhD completed within the past five years). This year's winner is Sutee Anantsuksomsri (with co-author Nik Tontisirin) from Chulalongkorn University, Thailand. The title of Sutee's paper was, "*Land Value Capture as a Funding Source for Public Transport: a case study of the Bangkok Metropolitan Region.*" Congratulations Sutee!

The Springer Prize is supported by the publisher of our official journal, *the Annals of Regional Science*, and qualified papers are judged by the team of editors. The prize consists of a certificate and a book voucher for \$500.

This year the board made one addition to its ranks: Richard L. Wobbekind. Richard is the Executive Director of the Business Research Division and Senior Associate Dean for Academic Programs at the University of Colorado, Boulder. In this capacity, Richard is responsible for developing an annual
